ANIMAL KEEPING BUSINESS LICENSE

City of Norco's business license term is for a twelve month period starting July 1 and ending every year on June 30. Please complete the business license application for an Animal Keeping business for the City of Norco and submit with the following:

- A City Business License is necessary ***PRIOR*** to commencing work in the City of Norco. A ***100% PENALTY*** is enforced for non-compliance.
- This application ***does not*** constitute a valid business license and ***will only be considered valid*** once all departmental approvals have been obtained and a business license has been issued by the City.
- If you are going to use a name other than your legal surname, you will need to file a "Fictitious Business Name Statement" with the County of Riverside Recorder's Office. We will need (1) copy for our records.
- If you are Incorporated or you are a Limited Liability Company (LLC) we will need (1) copy of your Articles of Incorporation or LLC that you file with the Secretary of State.
- We will also need (1) copy of your current valid driver's license/ID for identification purposes.

License tax is computed as follows:

June 1st – December 31st

Processing fee	\$ 35.00
Business license tax	\$ 45.00
SB-1186 Fee	\$ 1.00

Prorated: January 1st – May 31st

The business license tax fees are pro-rated to 50%. The processing and SB-1186 fees remain the same.

SB-1186 Fee – New or Renewal of Business License

On September 19, 2012 Governor Brown signed into law SB-1186 which adds a state fee of \$1 on any applicant for a local business license or similar instrument or permit or renewal thereof. The purpose is to increase disability access and compliance with construction-related accessibility requirements and to develop educational resources for businesses in order to facilitate compliance with federal and state disability laws, as specified.

Under federal and state law, compliance with disability access laws is a serious and significant responsibility that applies to all California building owners and tenants with buildings open to the public. You may obtain information about your legal obligations and how to comply with disability access laws at the following agencies:

CHAPTER 18.3, A-1 ZONE, AGRICULTURE LOW DENSITY

This zone is intended to provide for and encourage the development of agriculturally-oriented low-density living areas designed to take advantage of the rural environment, as well as the outdoor recreation potential of the community.

Permitted Uses:

1. Single family detached dwelling (one per lot)
2. Public parks and playgrounds
3. Accessory buildings (structures shall not be used as habitable dwellings)
Including:
 - a. Private garages (not to exceed four (4) vehicles)
 - b. Barns, tack room, corrals, cabanas, laundry rooms, etc.
4. Home occupations (NMC Chapter 18.32).
5. Agricultural uses:
 - a. Farms devoted to hatching, raising, butchering, or marketing of poultry, rabbits and other small farm animals on a commercial scale.
 - b. Nurseries, greenhouses, aviaries, apiaries and farming of fruit, vegetables and field crops.
 - c. The keeping of horses, cattle, swine, sheep and goats
6. Adult animal units shall be determined as follows:
 - a. One (1) horse or cow equals one (1) animal unit (under six (6) months-animal not counted)
 - b. Two (2) sheep or goats equal one (1) animal unit (under 61 days-animal not counted)
 - c. One (1) swine equals (1) animal unit (not more than one (1) swine shall be allowed for each 10,000 square feet of property)
7. Maximum number of adult animal units permitted in relation to lot size shall be determined as follows:

10,000-12,500	One (1)	0
12,500-15,000	Two (2)	0

30,000-35,000	Seven (7)	50
35,000-40,000	Eight (8)	63
40,000-45,000	Ten (10)	75 (maximum unless property is over 5 acres)
45,000-50,000	Twelve (12)	
50,000-55,000	Fourteen (14)	
55,000-60,000	Sixteen (16)	
over 60,000	One additional unit for each 4,000 sq. ft. over.	

No animal unit or offspring thereof shall be kept or maintained at a distance less than 35 feet from a dwelling located on an adjacent lot unless there is a 6-foot solid fence or wall. Under no circumstances shall a swine be kept closer than 35 feet from a dwelling on an adjacent lot.
