PUBLIC NOTICE IS HEREBY GIVEN that the City of NORCO, as AGENCY, invites sealed bids for the above stated project and will receive such bids in the offices of the City Clerk up to the hour of **2:00 p.m. on Tuesday, January 28, 2020**, at which time, or as soon thereafter as practicable, they will be publicly opened and read aloud.

The work to be done consists of furnishing all materials, equipment, tools, labor, and incidentals required for the above stated project as set forth in the Specifications, Drawings, and Contract Documents therefore, and to perform all work in the manner and time prescribed therein. All bidders must be Garland Certified.

There are 120 working days allowed to complete this project. Liquidated damages shall be assessed at \$500.00 per working day.

A full set of Contract Documents as described above may be viewed and obtained from the City of Norco Parks, Recreation and Community Services Department at 2870 Clark Avenue, Norco upon payment of a **\$40.00 non-refundable fee** (\$45.00 if mailed, including FEDEX and UPS) beginning **December 18, 2020**.

Any Contract entered into pursuant to this notice will incorporate the provisions of the State Labor Code. Compliance with the prevailing rates of wages, apprenticeship employment standards, and Contractor registration program established by the State of California Director of Industrial Relations will be required. Affirmative action to ensure against discrimination in employment practices on the basis of race, color, national origin, ancestry, sex, or religion will be also required.

Bids must be prepared on the approved proposal forms in conformance with the Instructions to Bidders and submitted in a sealed envelope plainly marked on the outside:

“SEALED BID FOR CITYWIDE ROOF PROJECT - DO NOT OPEN WITH REGULAR MAIL.”

Each bidder is hereby notified of a mandatory pre-bid meeting on Wednesday, January 15, 2020 at 9:00 a.m. Bidders not attending this meeting will be disqualified as non-responsive. The location of the pre-bid meeting will be at Nellie Weaver

Hall, 3737 Crestview Drive, Norco. Enter the George Ingalls Equestrian Event Center at Gate 3. Proposals by Bidders that do not attend this mandatory pre-bid meeting will not be considered.

At the time of Contract award, the prime contractor must possess a minimum C-39 license to perform the work.
