Re: City of Norco Seeking Applications for One Vacated Seat on the City Council

November 24, 2010

The City of Norco is very saddened by the passing of Mayor Malcolm Miller on Wednesday, November 17, 2010. In accordance with the California Government Code, if a vacancy occurs in an elective office, the Council shall, within 30 days from the commencement of the vacancy, either fill the vacancy by appointment or call a special election to fill the vacancy. At a Special Meeting held today (November 24, 2010), the City Council voted to fill the vacancy for the remaining unexpired term, ending November of 2011, by appointment.

Requirements to serve on the City Council are as follows:

- Must be 18 years of age;
- A United States Citizen;
- A registered voter of the City of Norco; and
- A resident of the City of Norco.

Applications will be available on Monday, November 29, 2010, at City Hall and on the City's website at www.norco.ca.us. The deadline for the receipt of applications is 5 p.m. on Wednesday December 8, 2010. Applications are scheduled to be considered by the City Council at a Special Meeting to be held at 7:00 p.m. on Monday, December 13, 2010.
