The City of Norco is accepting applications to fill the following vacancies on City Commissions:

<u>Historic Preservation Commission:</u>	3 Vacancies
<u>Parks and Recreation Commission:</u>	1 Vacancy
<u>Planning Commission:</u>	1 Vacancy

There are also 3 vacancies on the City's Economic Development Advisory Council (EDAC).

Any resident of the City of Norco may serve on a City commission. No member is selected on the basis of representing a specific business, district, organization, or cause. Requirements to serve on the Commission are as follows:

Service on City Commissions is a 4-year term; you must be a permanent resident of Norco, 21 years of age, and a citizen of the U.S.; and you must take the oath of office.

Historic Preservation Commission members shall be persons who, as a result of their education, training, knowledge, and experience are qualified to analyze and interpret architectural and site planning information, including but not limited to, licensed landscape architects and architects, urban planners, engineers, and licensed general contractors. At least two of the members shall have professional experience in urban planning, architectural history or historic preservation, archeology, American studies, cultural geography, cultural anthropology and shall have general knowledge of architectural styles prevalent in the Historic Old Town of Norco. Please include your qualifications for this Commission on your application!

EDAC membership shall be defined and appointed as follows:

- **EDAC members will be recommended by the EDAC and appointed by the City Council;**
- **Nine members will serve on the EDAC, including two members of the City Council; and**

- **New members appointed to the EDAC will be selected from the business community. Members are not required to live in Norco; however, members should have a significant stake in the success of the business community.**

An appointment to a commission is an honor and a responsibility. The City Council has confidence in the judgment and integrity of its appointees and relies on them for information and recommendations on specific matters. As advisors to the Council, commission members are expected to regularly attend meetings, understand their duties and roles, and work to contribute to the betterment of the community.

The **deadline** for receipt of applications for appointments to the above listed commissions and EDAC is **6 p.m. on Thursday, May 9, 2013**. The Norco City Council will consider and make the appointments to the commissions at its first Regular Meeting in June.
